



Rules of the "Volleyball at School Project" contest

1. ORGANISER AND CONTEST

The "Confédération Européenne de Volleyball", a non-profit association, registered at the Company register of Luxembourg under the number F1135, with its headquarters at 488 route de Longwy, L-1940 Luxembourg, hereinafter "the CEV", organises a contest named "Volleyball at School Project", hereinafter "Contest", according to the present document, hereinafter "Rules".

The Contest is organised with regard the CEV project "Volleyball at School", hereinafter "the Project". The Project has been designed in order to grow Volleyball by involving physical teachers and their students in primary schools. The CEV aims to create the logo and motto or name of the Project, with the support of Volleyball fans.

The Contest is free and without prior obligation to purchase.

2. REQUIREMENTS FOR ADMISSION

Participation in the Contest is open to any natural person, hereinafter "Participant".

When the Participant is a minor, an authorisation from the legal representative is mandatory.

Participation in the Contest is forbidden to any employees or representatives of the CEV, natural persons involved directly or indirectly in the organisation and running of the Contest and first degree relatives of the above mentioned persons.

3. PERIOD

Participation in the Contest is open from Friday, 27 January 2017 to Sunday, 12 March 2017 12:00 PM CET.

4. PARTICIPATION

Participation in the Contest is exclusively done according to the provisions of article 5 of the Rules. Any other way of participation is excluded.

Participation in the Contest is not limited to one single entry per Participant. When there are several participations in the Contest per Participant - same first name and last name - the CEV shall only take into consideration all valid participations of the Participant.

Participation in the Contest is considered valid when all the requirements mentioned in article 5 of the Rules are fulfilled.

Each Participant commits to participate in the Contest according to the Rules. Any breach of the Rules may lead to the dismissal of the participation of the Participant in the Contest.

5. RUNNING OF THE CONTEST

§1 The Contest is run as follows:

- Each Participant shall create a logo and a motto or name related to the Project. The keywords "Volleyball", "Europe" and "School" shall be included in the creation. The motto or name should be in English. The artistic work shall summarise the spirit and essence of a project involving young pupils, students and Volleyball.
- Each Participant shall submit its artistic work to the CEV via email - development@cev.lu.
- The CEV, via a jury, proceeds to a first selection of artistic works and publish them on its social media channels.
- The users of the CEV social media channels are invited to vote for the best artistic works. Ranking is done according to the number of Facebook Likes.
- The CEV, via the same jury, proceeds to a final selection.

6. PRIZES

6.1 List of prizes

The prize is as follows:

Prize 1: one prize composed of a maximum of 5 tickets per match of the final phase of the 2017 CEV Volleyball Champions League - Men or Women (4 matches in total), with VIP access and a maximum allowance of EUR 1,000 (one thousand Euros) to cover the travel and accommodation costs.

6.2 Exchange and shipping

The CEV reserves the right to replace one prize per another of same value.

The CEV will send, at its own costs, the prizes to the provided addresses.

7. WINNER

One Participant, among those who fulfilled the requirements and successfully passed the stages mentioned in article 5 of the Rules, will be selected by a jury, hereinafter "Winner". The decision of the jury is final.

The jury is composed of eight people who are representatives or employees of the CEV. The selection criteria are the technical, esthetical quality and originality of the artistic work and fulfilment of the spirit and essence of a project involving young pupils, students and Volleyball. The jury is free to organise itself at its own discretion.

The CEV will contact the Winner in order to announce the decision of the jury.

When the Winner cannot be contacted within a period of 15 days from the announcement, the Winner is considered as having waived his/her right to the relevant prize.

When the Winner breaches the Rules, the CEV will not grant him/her the relevant prize.

The prize awarded to the Winner is not transferable, redeemable for cash or exchangeable.

8. RESPONSIBILITY

The CEV does not accept any liability with regard to the participation in the Contest, the modification of the Rules, suspension or termination of the Contest.



The CEV does not incur any liability with regard to the breach of the Rules by a Participant or use of the prize of the Contest.

9. ACKNOWLEDGEMENT AND AGREEMENT

By participating in the Contest, each Participant agrees automatically and unreservedly to the Rules. Each Participant is deemed to have read, understood and agreed with the Rules before participating in the Contest.

Each Participant acknowledges that the CEV will not take into consideration its artistic work which directly or indirectly, by any means and in any form, suggest or refer to some content which are likely prejudicial to individual's health and safety and/or harm any person due to its sex, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth or other status.

Each Participant agrees that his/her personal data are processed according to article 10 of the Rules.

Each Participant acknowledges and agrees with article 11 of the Rules.

Each Participant acknowledges that it has all necessary rights, licences and consents to use the content of its artistic work.

Each Participant agrees that the CEV may terminate the Contest at any time in case of a breach of the Rules, third party's rights or legal provisions; as well as a situation of force majeure.

The Winner agrees that his/her image may be used for a period of one year from the decision of the jury, by the CEV, for the promotion of the Contest, on paper and in digital publications; and waives any claims to royalty, right, or remuneration for such use.

The Winner agrees to any verification by the CEV to ensure the compliance with the Rules.

10. PERSONAL DATA

Each Participant's personal data is being processed by the CEV with the aim of ensuring the organisation and running of the Contest, the compliance with the Rules, the distribution of the prize and the possible promotion of the Winner. These personal data are only communicated to the CEV. These personal data will be deleted no later than 3 months after the end of the Contest.

Each Participant is aware of his/her right to access, rectify or object the processing of the personal data. Any request shall be sent to the CEV - legal@cev.lu.

11. INTELLECTUAL PROPERTY RIGHTS

Each Participant is the original creator or author of the artistic work submitted to the CEV. If not, each, any and all author's rights, economic and moral, have been irrevocably and definitely transferred to the Participant, prior to the participation to the Contest. No other third party has any kind of rights on the artistic work submitted by the Participant.

Each Participant never used the artistic work submitted, prior to the Contest, for any kind of purposes.

Each Participant authorises the CEV to publish its artistic work on its social media channels, until the decision of the jury, without any financial compensation and for the purpose of allowing the selection mentioned in article 5. §1 of the Rules.

The Winner irrevocably and definitely transfers to the CEV each, any and all author's rights, economic and moral, of its artistic work to the CEV as well as any trademarks related to it; with the purpose to use or exploit the artistic work for the promotion, branding of the Project worldwide and on any paper and digital materials. The CEV has therefore the right to proceed to any modification of the artistic work. The



prize mentioned in article 6 of the Rules is considered as a financial compensation for the transfer of the above mentioned rights.

12. MISCELLANEOUS

The Rules are available during the period of the Contest on the CEV website - www.cev.lu - or upon written request to the CEV - legal@cev.lu.

The Rules are governed by the Law of the Grand Duchy of Luxembourg. The Rules constitute the law of the parties. Any dispute which is not settled in a friendly way shall be brought before the competent jurisdictions of the Grand Duchy of Luxembourg.

The Contest is in no way sponsored, endorsed or administered by, or associated with the company Facebook or Twitter. Each Participant acknowledges and agrees that the company Facebook or Twitter shall not be held liable for any dispute arising from the participation in the Contest.
